Soliciting and Canvassing License Application Process

- Complete the NJSP on-line background check request form – \$20.00 payment is required at the time of application
 - Browse to www.njportal.com/njsp/criminalrecords/
 - Click on **ON-LINE FORM** button in lower left corner
 - Complete all requested information – the ORI number is NJ0140500
 - A confirmation and receipt will be sent to the email address you provided. Print the confirmation and attach it to your application packet
- Complete the Chatham Township Permit Application in full.
- Two recent photographs must accompany the application. The photographs must be 1 ½” by 1 ½” in size.
- If you are not self-employed, a letter of representation, on the company’s or organization’s letterhead, signed by an officer of the company will be required.
- \$5.00 cash must accompany the application.
- **Once all of the above is completed or if any step cannot be completed, contact Detective Anthony LoPorto to make an appointment at 973-377-0100.**

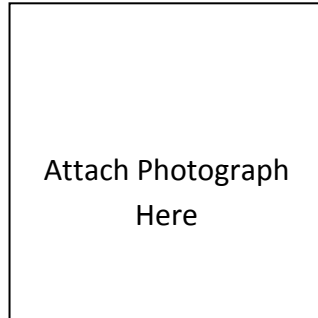

3. If you are not self-employed, a letter of representation on the company's or organization's letterhead, signed by an officer of that company will be required.
4. Annual Solicitor's Fee of **\$5.00 Cash, exact change.**
5. The application must be complete and fees, photos, confirmation documents and all other information requested must be included or issuance of the permit will be delayed.
